Fort Bend Seniors Meals on Wheels provides comprehensive services and programs including Meals on Wheels, congregate meals, transportation, case management, health screenings, information and referral services, recreation, respite care, and more. Each of these programs and services enables area seniors to remain in their homes and continue to be an integral part of the community for as long as possible.

HOME DELIVERED MEALS - FORT BEND AND WALLER COUNTY: The goal is to promote better health for eligible homebound older persons by providing nutritious home-delivered meals.

Clients must be 60 years of age or older and score a minimum of 20 on the Department of Aging and Disabilities Assessment. Eligibility is based on an assessment of: impairment in the ability to perform activities of daily living or instrumental activities of daily living; frequency of a person leaving his or her home or need assistance to do so; ability to prepare nutritious meals and shop for food, their nutritional risk, and financial resources available to the senior.

CASE MANAGEMENT - FBS provides individual assessments by a trained and degreed case manager to determine seniors' needs in the areas of social services, nutrition, and health care. Once an assessment is completed, FBS staff arrange for the appropriate services to be delivered and provide follow-up reviews to ensure needs are being met. Through case management a participant is assessed for the following services: home delivered meals, nutrition education in the home, assessment of needs, and appropriate referral to other services. To reduce potential exposure of the COVID-19

virus to both staff and clients, assessments were conducted via telephone beginning

in March 2020, rather than in-person.

HOME DELIVERED MEALS - The meals meet at least 1/3 of the recommended daily allowance of nutrients required by adults at least five days per week. During pandemic times, FBS provided 7 meals per week; pre-pandemic this included up to five hot nutritious meals Monday thru Friday, and two frozen meals delivered Friday for the Saturday and Sunday meals. Once the disaster declarations were announced for the local community and for the remainder of the year, FBS adapted deliveries to minimize potential exposure to the clients. This included once a week delivery of 7 frozen or shelf stable meals, use of PPE during the delivery process, enhanced cleaning procedures, and social distancing during deliveries. FBS also provides the homebound client a frozen holiday meal on or before the actual day of the holiday. All clients were contacted a minimum of 3 times per week to ensure they were healthy, consuming their meals, and had a microwave to properly warm their meals. Seniors interested in receiving services can contact Fort Bend Seniors' headquarters toll free at 1-800-643-9654.

EMERGENCY SHELF STABLE MEALS - Additionally, FBS provided 10 emergency shelf meals to each client to use during inclement weather when the agency is not able to make a delivery to clients.

VOLUNTEERS - Volunteers, part-time staff drivers, and site coordinators, are responsible for daily delivery of the meals. When volunteers deliver the meals, it reduces the operation cost for meal delivery enabling us to purchase more meals to serve seniors. Meals are delivered directly to the participants or an authorized caregiver. Pre-Covid, clients would give the delivery person permission to enter

their home. The Meals on Wheels program is more than just a meal delivery. Through our trained staff and volunteers, a homebound senior receives a warm smile, safety check to help ensure he or she is well and any other needs that are identified such as nutrition education may be addressed.

HOME DELIVERED OUTCOMES: In 2020, FBS delivered 320,099 meals - more than ever in our history - to 1,424 homebound eligible senior citizens in Fort Bend and Waller County. Each week the pandemic continued, we welcomed new seniors to the program - many of whom were fearful to leave their homes. At the onset of the pandemic, FBS leadership committed to providing meals to any of our clients, as well as seniors newly in need, throughout the community. Since the initiation of the stay-home orders through the end of 2020, we added 569 new clients to our programs. Of the 2,188 total clients served (including congregate participants) over the course of 2020: 68 percent lived alone or with their elderly spouse; 21 percent were veterans or surviving spouses of veterans; 70 percent represented minority populations, of which are largely African American and Hispanic. Through our annual satisfaction survey of the Home Delivered Meal Clients we have confirmed that the meals on wheels program 1) promotes better health for homebound elderly through improved nutrition and 2) alleviates the isolation of the homebound elderly by the daily visits during meal delivery.

When a client enters the program, an Intake and Nutritional Risk Screening is completed to determine the nutritional risk and needs for the participant which enables the staff to assist with improving the participant's health. The participant is eligible to choose to participate in all the following services:

CONGREGATE MEALS - Congregate meals include one hot meal daily that meets at least 1/3 of the recommended daily allowance of all nutrients required by adults provided in a group setting. An integral part of the Meals on Wheels program, Fort Bend Seniors provides congregate meals five days per week at 7 locations in Fort Bend and Waller counties. The 7 site locations providing services Monday through Friday are open from 9 am to 12:30 pm. Seniors interested in receiving services can visit the Fort Bend Seniors' site nearest them or contact Fort Bend Seniors' headquarters toll free at 1-800-643-9654.

EMERGENCY SHELF STABLE MEALS - Emergency shelf stable meals are meals with a shelf life of one year that are delivered to seniors for use when home delivery is unavailable due to emergency weather conditions. FBS provides 10 meals annually to homebound and congregate Meals on Wheels participants.

RECREATION - Pre-pandemic & currently, FBS provides daily recreational opportunities for seniors who attend the congregate meal program. A monthly calendar of events is provided to seniors outlining upcoming recreational and social programs. Activities include field trips, arts and crafts, bingo, exercise, dancing, and holiday events giving seniors an opportunity to socialize with their peers on a regular basis.

RESPIRE CARE PROGRAM - Pre-pandemic, half-day program for clients with the beginning stages of Alzheimer's Disease or dementia to allow family members a break from care giving responsibilities, while their loved ones participate in planned activities such as games, music, arts, crafts, lunch, and socialization.

HEALTH SCREENINGS/NUTRITION EDUCATION - FBS provides vital health screenings for seniors at their congregate sites. The program includes screenings for hearing, vision, depression, and other senior related health screenings on an annual basis. Nutrition education programs are also provided through this program. These services are provided by volunteers that are professionals in health screenings and nutritional counseling.

INFORMATION AND REFERRAL - FBS maintains a database of important information relating to seniors and their needs. Vital information is provided to seniors in need of services and opportunities and referrals are coordinated by FBS staff.

CONGREGATE OUTCOMES: In 2020, Fort Bend Seniors provided 117,897 meals - more than ever in our history - to 764 congregate clients in Fort Bend and Waller County. The COVID-19 pandemic had far reaching effects on our community, not the least of which was on FBS congregate center participants. Out of an abundance of caution and in line with local and national health recommendations, FBS leadership made the decision to temporarily close FBS' twelve center programs beginning March 16, 2020. However, they also committed to providing meals to each of these clients, as well as seniors newly in need. Thus, all former congregate center participants were offered home-delivered meals at no charge to them for the remainder of 2020, about half of whom gratefully accepted.

TRANSPORTATION: FBS contracts with Fort Bend County Public Transportation to provide transportation for our participants in the Congregate Meal Program. The vehicles are air conditioned, handicapped accessible vans. The service is door-to-door, transporting the client from their home to the nearest senior center, and then returns the client home following program activities. These rides were only for participants in Fort Bend County centers. Waller County service is provided through Colorado Valley Transit Services at no cost to the client or to FBS.

CLIENTS: Includes Senior Citizens 60 years of age and participating in one of the congregate senior center meals programs in Fort Bend County. FBS maintains files containing information that identifies regular participants, documents eligibility and information on emergency contacts.

UNIT OF SERVICE: A unit of service is a one-way trip provided to an eligible person from one location to another. Each client is eligible for two units of service per day. The service is provided five days per week (Monday-Friday).

TRANSPORATION OUTCOMES: In 2020, FBS provided 5,356 rides to senior participants to and from congregate senior centers under the contract with Fort Bend County. This was 81 percent fewer rides than previous years, as the closure of the congregate centers due to the pandemic necessitated the cessation of transport services. Revenue and expenses related to the transportation program were also dramatically impacted. Participants in need of transport for various needs were still able to book on-demand transport separate from FBS.
